I am experienced in commercial, construction and investment arbitration and have acted in arbitrations under various arbitral institutions including ACICA, LCIA, ICC, SIAC, CIETAC and JCAA

I am on the arbitrator panels of leading arbitral institutions including the Chartered Institute of Arbitrators, the Singapore International Arbitration Centre, the Australian Centre for International Commercial Arbitration, and the Resolution Institute, among others. 
